



### MAYOR'S CORNER

#### Legislative Update

I thought in every way that the third time would be the charm on our sales tax issue with the State Legislature. It was not. We had asked simply that the base year for our minimum sales tax distribution be adjusted from fiscal year 2005 to fiscal year 2006. On July 1, 2006, the Legislature took away our hold harmless provision that had protected and preserved Riverdale City's sales tax distribution at \$0.75 per sales tax dollar since 1983. Again, in this 2008 Session, they refused to make that simple adjustment as a way to restore about \$400,000 per year to offset the nearly \$2 million in lost revenues that we have suffered thus far.

I again want to thank our northern Utah delegation, Representative Brad Dee especially. He worked long and hard along with Senator Scott Jenkins to get both sales tax relief as well as the required additional road funds for the Riverdale Road widening project. The vote on the House Bill 172 that Rep. Dee sponsored and ran as a priority bill for sales tax passed the House 70-0. In the Senate, a Utah County Senator vowed to never let it pass and said he would kill the bill first.

#### Alternate Funding

Many maneuvers were used to try to keep it alive but in the end the only thing that was given as an alternative funding source is the authorization for Riverdale City to pass up to a 0.20% local option sales tax increase. Mr. Hansen and Mr. Fortie are now crunching the numbers to see what the short and long term effects will be on our city if we were to implement this tax.

A major upside that we can see at first glance is that the non-resident shopping population will likely pay the majority of these taxes as opposed to residents of our city. This could also help us avoid having to raise property taxes again. We will give you more information as we look at this during the budget process. Any such tax could not be effective until January of 2009 but for budget purposes we will have to decide as the budget for fiscal year 2009 is adopted. We certainly feel the 2008 Legislature has again dealt unfairly with us and the other three cities in the same circumstance as ours. Moving forward we will try to find a way to make lemonade with the lemons we have been given.

### SPRING CLEANUP



Our Spring Cleanup has been scheduled for Saturday, April 19<sup>th</sup>. Roll off dumpsters will be placed at locations around the City for residents to bring refuse items for disposal. Locations are as follows:

#### Locations and Times:

- Riverdale Park 8:00 a.m. - 2:00 p.m.
- Golden Spike Park 8:00 a.m. - 1:00 p.m.
- 525 West 4800 South 9:00 a.m. - 12:00 p.m.

At each location there will be two roll off dumpsters: one for green waste (tree limbs, weeds, etc.) and one for other items. Please follow these steps when bringing items to unload:

- **Warning: Tree limbs not tied in bundles will be rejected.**

**Important:** Tree limbs must be tied into bundles 6 feet long or less. Bundles unload 10 times faster than loose limbs. This keeps things moving for everyone.

**Tip:** When pruning, lay twine or heavy string down in strips. Stack trimmings on top of twine and then simply tie together tightly. It really makes it faster to load and unload; and you will get more on your load.

- Please bring enough help to unload quickly.
- The attendant will not be able to help you unload.
- Children must remain in vehicles for safety reasons.
- Items that will not be accepted include: tires, chemicals, paint, dirt, concrete, rocks, batteries, pesticides, drums, and hazardous waste.

## CRIME REPORTS AVAILABLE ONLINE

The Riverdale Police Department has partnered with the Utah Attorney General's Office and Public Engines, a software development company, to provide the ability to share neighborhood crime incident information through the Internet. The service is currently available online at the website [www.crimereports.com](http://www.crimereports.com). There is also a link from the Police Department page on the city website, [www.riverdalecity.com](http://www.riverdalecity.com).



This service allows our department to report local crime incident data in a near real-time stream through the CrimeReports.com website. The program converts raw crime data into easily accessible information, using a Google Maps interface, for anyone to view for free via the Internet.

A second benefit of this service is the ability to receive email alerts containing the type, date, and block address location of crime incidents in your neighborhood. Located in the upper right hand side of the CrimeReports.com website is "Join and receive free crime alerts." This is a page that allows users to sign-up for e-mail alerts by specifying the address, crime types, and distance from a chosen address.

It is important to understand that due to the timeliness of the reporting, investigations will not yet have been completed, and the information will be preliminary and subject to change during the course of the investigation. Crime incident data will be updated nightly by the police department.

The Riverdale Police Department has for many years set a high priority on community policing. CrimeReports.com gives us another tool to keep our community informed and to strengthen the department's partnership with the people we serve. When community members know what crime is occurring in their neighborhoods, they can better prevent themselves from becoming victims, and may be more apt to report to police any suspicious persons and activities that may be related to those crimes. This is the first stage of an evolving program with additional information and features to be added.

## OPEN BURN SEASON

The Weber County Fire Marshall has designated the month of April as 'Open Burn Season' allowing citizens to burn leaves, small branches, grass clippings, and other vegetation. This is the only time of the year that open burning is allowed for non-agriculture residents. Homeowners wishing to burn must receive a burn permit from the Riverdale Fire Department and abide by the following:



1. Inspection by the fire department before the burn.
2. Permits are only good for the day issued.
3. A water source must be available at each fire.
4. All fires must be monitored at all times and must be out by dusk.
5. If a fire gets out of control call 911 for assistance.

Farmers with more than 5 acres of land in the green belt can burn any time of the year with a permit from the Fire Department. ### FREE TAX HELP FOR SENIORS


The last session of the AARP free tax help for seniors will be on April 10<sup>th</sup> at the Senior Center. To participate, please sign up at the Center.
