Riverdale's RDA hurts helps tax revenue!

Passing up \$1 in city revenue for \$11 in Redevelopment Agency (RDA) revenue made sense in the Fiscal Year (FY) 2007 budget and very frankly has made sense to the Mayor and City Council (and the RDA Board who serve as one and the same) for years dating back to FY 1993.

Contrary to a recent media report suggesting that Riverdale residents/taxpayers are hurt by the RDA, a staff review of FY 2007 city and RDA property tax revenues shows:

The \$1,012,665 actually received vs. the alternative of \$113,194, represents the difference in taking advantage of an opportunity to stretch taxpayers dollars for the beneficial use of the community. This multiplier effect of increasing and leveraging revenues does make a big difference to residents of Riverdale. Over the years this has helped us stretch the city's general fund revenues by adding millions of RDA dollars. This has become even more important with the loss of sales tax dollars in the 2005 state legislative session.

For example, through the use of the RDA projects and as a result of our redevelopment efforts:

- Over \$1.5 million has been provided, and will continue to grow, for qualifying resident home owners for a perpetual rehabilitation housing loan program. Another \$1 million plus will be added to this amount from the new JC Penney shopping center.
- Over \$5 million in value has provided our city with a wonderful new senior center, apartments, activity rooms, and a gathering place.

At each location there will be two roll off dumpsters: one for green waste (tree limbs, grass, leaves, etc.) and one for other items. Please follow these steps when bringing items to unload:

- Please bring enough help to unload quickly.
- The attendant will not be able to help you unload.
- **Cut and bundle tree branches for quick unloading.**
- Children must remain in vehicles for safety reasons.
- Items that will not be accepted include: tires, chemicals, paint, dirt, concrete, rocks, batteries, pesticides, drums, and hazardous waste.

MAYOR'S CORNER CONTINUED

- Nearly \$2 million has been provided to enhance and complete the construction of 900 West and River Park Drive (behind Sam's and Wal-Mart), it's utility infrastructure and roundabouts.
- Over \$3.8 million more from the new JC Penney shopping center will pay for the land and construction of our new 550 West road (an additional access to and from Pacific Ave and Newgate Mall), infrastructure, and power-line relocation.

The use of these many millions of RDA dollars has allowed the city to use its general fund surpluses over the years to fund capital projects such as Riverdale and Golden Spike Park and Weber River trail enhancements, streets and building projects, etc. As your elected officials, we recognize our duty to use your tax funds carefully, wisely, and appropriately. We would feel remiss in our performance if we did not take advantage of continuing the wise use of our RDA project areas in any way permissible to benefit Riverdale residents.

Thanks to all of you for what you do to make our City Great.
