**A. Welcome & Roll Call**

The City Council meeting began at 6:00 p.m. Mayor Searle called the meeting to order, welcomed all in attendance, and stated Councilmember Arnold participated via conference call. Mayor Searle reminded members of the audience to sign in.

**B. Pledge of Allegiance**

Mayor Searle invited Councilmember Hansen to lead the Pledge of Allegiance.

**C. Moment of Silence**

Mayor Searle called for a moment of silence and asked everyone to remember our police officers, fire fighters, U.S. Military service members, and members of the City Council as they make decisions this evening.

**D. Open Communications**

Mayor Searle invited any member of the public with questions or concerns to address the Council and asked that they keep their comments to approximately three minutes.

There was a boy scout in attendance earning his citizenship merit badge.

**E. Presentations and Reports**

**1. Mayors Report**

Mayor Searle reported on the Riverdale City booth at the Weber County Fair. It was noted resident Camee Ellis won the people choice award for her use of pictures in assembling the History of Riverdale Book.

Mayor Searle discussed the newly added trail connection located near Riverdale Elementary which connected 4300 South to the school property.

Mayor Searle provided an update regarding the Bonneville Communities that Care (CTC) and encouraged Riverdale Residents to be a part of the organization.

**2. City Administration Report**

Rodger Worthen summarized the staff reports, employee anniversaries (including recognizing 5 year anniversary employees), Community Development Report and the Financial Report. It was noted the Utility Report included prior year comparisons in data.

Mayor Searle recognized Jim Harvey, a Weber County Commissioner, who was in attendance.

**3. Communities that Care (CTC) Activities Report**

The CTC members introduced each member and summarized their recent training at Snow College. The training emphasized strategies to prevent underage drinking, suicide, and bullying.

The City Council and City Administration all thanked the CTC members for their participation and continued efforts in teenage drug and alcohol prevention.

**F. Consent Items**

**1. Consideration of approving meeting minutes for the City Council Work Session and Regular Meeting minutes held on August 1, 2017.**

Mayor Searle invited any corrections or comments for the City Council Work Session and Regular Meeting minutes held on August 1, 2017. There were no requested changes.

**2. Consideration to set a public hearing for September 5, 2017 to receive and consider comments regarding a property exchange for property located approximately 1500 West Ritter Drive, Riverdale, Utah 84405 between Riverdale City and Anderson Development LLC.**

Mr. Worthen explained this property is owned by Riverdale City and is a leftover parcel which was originally acquired as part of the street completion of 1500 West. This exchange is for the purpose to enhance the road, Ritter Drive. More information will be available at the next City Council Meeting.

**MOTION:** Councilmember Hansen moved to approve the consent items as proposed. Councilmember Mitchell seconded the motion. There was not any discussion regarding this motion. The motion passed unanimously in favor.

**G. Discretionary Items**

Councilmember Mitchell commented regarding the section of Riverdale Road that was fixed. He believed it was directly related to the Utah Department of Transportation phone application that allows anyone to report hazardous roads. He encouraged people to continue to report hazardous roads.

Councilmember Hansen noticed an increase in the City social media and encouraged the City to continue their efforts.
